



LIFETIME LIMITED WARRANTY

Procell Decking Systems are warranted by the Manufacturer, PRO-CELL, L.L.C., to be free from defects in material and workmanship, set forth in the following paragraph, occurring as a direct result of the manufacturing process, under normal use and service, during the period stated and subject to the terms and conditions of this warranty. This warranty is valid only in the United States.

Procell Decking Systems are warranted against manufacturing defects in material and workmanship that result in blistering, peeling, flaking, cracking, splitting, cupping, rotting or structural defects from termites or fungal decay.

Notification

Should your Procell Decking System show defects at any point, Purchaser/Homeowner must notify Procell Decking Systems in writing within 30 days after discovering the claimed defect and prior to beginning any repair or alteration to the Procell Decking Systems product. The notice must include a detailed description of the claimed defect, a photograph(s) of the defect and proof-of-purchase. All claim requests should be mailed to:

A reasonable time period should be allowed for inspection purposes. If, after inspection, the Manufacturer determines that the claim is in accordance with the terms of this Lifetime Limited Warranty, the Manufacturer will repair or replace at its sole discretion, the defective material, or will refund the original purchase price of the defective material. The Manufacturer will not be liable for labor and/or removal costs connected with the claim. Replacement product will be provided as close to the original as possible, although not guaranteed to match completely. In the event of repair or replacement, the original warranty shall apply to the repaired or replaced portion of the decking material and will extend for the balance of the warranty period in effect at the time the material proved defective.

Limitations

This Lifetime Limited Warranty is void if any of the following occurs: (a) improper installation and/or failure to abide by the Manufacturer's installation guidelines; (b) movement, settling,

distortion or collapse of the ground or supporting structure on which the Procell Decking System is installed; (c) naturally occurring casualties including impact of objects, earthquakes, tornados, hurricanes, lightening, flooding or acts of God; (d) improper handling, storage, neglect or misuse of the product either by the Purchaser or third parties; (e) improper application of paint or other surface chemicals not recommended by the Manufacturer; (f) adverse effects of air pollution and normal weather of surfaces.

Other Conditions

The Manufacturer does not recommend this product for all end use applications. This product is intended for deck, boardwalk and piers. Local Code Authority should be consulted before installation of and structures with specific load bearing capacities or other zoning code requirements. This Lifetime Limited Warranty is valid on single-family, residential applications only. For all other entities, such as commercial use, this warranty shall be in effect for a period of twenty (20) years. THE WARRANTY STATEMENTS CONTAINED IN THIS LIFETIME LIMITED WARRANTY SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY PROCELL DECKING SYSTEMS, IN LIEU OF ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF PROCELL DECKING SYSTEMS AND THE PROPERTY OWNER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. PROCELL DECKING SYSTEMS SHALL NOT BE LIABLE TO THE PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THIS PRODUCT.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Lifetime Limited Warranty gives you specific legal rights and you may also have other rights that vary from state to state.
